The Board of Commissioners met in an agenda session with Mayor Quinn presiding. Members present. Quinn and Parent. Absent: Hollingshead, Shannon and Derella.

Mayor Quinn stated the three Commissioners must be present to constitute a quorum noting due to two unforeseen medical situations and an unforeseen business obligation have resulted in the absence of the three Commissioners.

Mayor Quinn announced the Commission Meeting cannot be conducted since there is less than a quorum present.

Mayor Quinn noted the Year End Meeting will be held on Tuesday, June 26, 2007 at 12:00 noon, which is the Fiscal Year for the City of Millville and the Resolutions that are on the agenda tonight will be placed on the agenda of the Year End Meeting.

Mayor Quinn also noted the meeting will not be televised, because the County College is on during the day at that time.

Mayor Quinn referred to the City Clerk/Administrator, Lew Thompson.

The City Clerk/Administrator noted that the City of Millville's Annual End of the Year Meeting is already scheduled for Tuesday, June 26, 2007 at 12:00 Noon and indicated the required Resolutions, necessary payment of bills, regular business and the temporary budget, which is regularly scheduled for the End of the Year Meeting, will be on the agenda.

The City Clerk/Administrator added the Budget will likely be introduced sometime in August noting the temporary budget will enable the City of Millville to operate for approximately the 120 days until the adoption of the final budget, which will hopefully take place in October or November.

The City Clerk/Administrator noted all the Ordinances for first and second reading that are on tonight's agenda will be scheduled on the agenda for the Commissioner Meeting that will be held on Tuesday, July 3, 2007 at 7:00 p.m. or immediately thereafter in order to have the public hearings.

The City Clerk/Administrator further noted the Ordinances that were scheduled for a public hearing this evening will be re-advertised.

The City Clerk/Administrator also stated the annual Alcoholic Beverage License renewals scheduled for tonight's meeting will take place at the End of the Year Meeting on Tuesday, June 26, 2007, 12:00 Noon, because they are required to be approved for operation on July 1, 2007.

Commissioner Parent noted the swearing-in of three firefighters that occurred tonight prior to the meeting and announced the swearing-in ceremony will be broadcast on Channel 13 on Wednesday and Thursday at 7:00 p.m.

Commissioner Parent stated he and the Mayor will be available after the meeting for the people who are in attendance this evening to address any concerns they may have.

There being no further comments the meeting was adjourned subject to the call of the chair, by the following vote: Yeas: Parent and Quinn.
