The City Clerk/Administrator read correspondence from the County of Cumberland Department of Public Works Mosquito Control Division requesting permission from the City of Millville to apply pesticides as needed by aircraft or ground unit (truck) in the City of Millville during the 2009 spray season.

A motion was passed to receive, file and approve the appointment, by the following vote. Yeas: Parent, Derella, Shannon, Vanaman and Quinn.

The City Clerk/Administrator read a letter from W. James Parent, Director of Public Works, appointing Steven M. Pierce to the position of Water Treatment Plant Operator in the Department of Public Works in accordance with certification from the New Jersey Department of Personnel effective March 17, 2009

A motion was passed to receive, file and approve the appointment, by the following vote. Yeas: Parent, Derella, Shannon, Vanaman and Quinn.

Commissioner Shannon: *"As I mentioned earlier, I would just like to remind everyone about the rules and regulations governing the City Parks throughout the City of Millville and although some people may find it amusing that I'm going to remind people of this, we're going to be taking this very seriously this year, as we've done in the past. We've had quite a few calls already about people in the parks, the possible use of drugs, alcohol, weapons and things of that nature are not allowed and will not be tolerated. We've had some complaints already and I've worked very closely with Commissioner Vanaman and have been in contact with the Millville Police Department and we're going to be cracking down on that type of behavior. We want our folks to be able to go into the parks and enjoy them, but loud music, again alcohol, drugs, weapons and things of that nature we will prosecute to the fullest extent of the law. So, please obey the rules, enjoy the spring and summer, but lets keep things under control."*

The Permit Fee Log Report and the Monthly Fees Report for the month of February 2009 were ordered received and filed, by the following vote. Yeas: Shannon, Parent, Derella, Vanaman and Quinn.

Commissioner Parent also announced the Annual April Leaf and Brush Collection will continue through the month of April and to please have them separate to facilitate the pickup and reminded everyone that the leaves do not have to be bagged.

The Tax Collector's Report for the month of February 2009; Accounting Report for the month of February 2009 and the City of Millville Report of Invested Funds Money Market Account for the month of February 2009 were ordered received and filed, by the following vote. Yeas: Shannon, Parent, Derella, Vanaman and Quinn.

Commissioner Vanaman: *"I have a few items here that I've already warned the press that it's all good news stuff, so it doesn't get that much coverage. Last week Cumberland County combined the Fire and EMT Chief's Association had their Annual Awards Banquet and this year four Millville firemen were designated as the County Award Winners for Firefighter of the Year and that was Deputy Chief Howard Hee, Firefighters Keith Mitchell, Dave Smith and Mike Calchi for their lifesaving efforts last August at the Morias Avenue fire. So, that was countywide recognition. Also, they do an EMT recognition for County EMT Personnel of the Year and that was two individuals from Millville Rescue Squad, Dave Chiola, who is currently away serving his country and also Dave Ernst, so that was real good publicity for the City of Millville and just once again shows what a great job that our people are doing. I have the monthly Fire Department Report to submit, once again the station calls continue to increase, as the all calls decrease and we've now reached a level of almost 60 percent of all the calls for the month that have been handled solely by the on duty crew, without the need to put a whole bunch of fire trucks on the road. So, I consider that a lot of good news. I wish gas was still \$4.00 a gallon and then we'd be saving a lot more. One more thing, because Jason already asked me. There was a small group that did a walk around today, if you noticed 35-40 suits walking*

around, they were all lawyers. There was a meeting with Verizon and Atlantic Electric and it looks like we're finally getting the approval and the go ahead to install the cameras and the poles that have been selected I understand there's like 3 locations that have to be moved, but we will be proceeding along with that and a little bit later on in the meeting there's going to be a resolution also addressing the camera situation. Now, for the best part of the whole report I'm going to move over here and I won't be 30 minutes. Again, in all seriousness as I said a few minutes ago, too often the news media likes to dwell on the bad news, if a policeman does something bad, you're going to read about it front page, probably 2, 3, 4 or 5 days in a row. The good news kind of gets lost in the shuffle a lot of times. There's two individuals here tonight that we're going to recognize for some very well done lifesaving efforts and at this time I would like to call up Sergeant Tom Haas and Officer Rich Reynolds. We had an incident a couple or three weeks ago where it became known to the Millville Police that an individual was possibly and probably attempting to cause severe and grave danger to himself. Patrolman Reynolds was the first responder that got there and he was alerted to the situation that someone had barricaded himself inside of a small shed behind the house and when he went to the shed he could not get into it, so he forcibly was able to gain entry and when he realized that there were dire consequences occurring, shortly after that Sergeant Haas was able to pull up and back him up and between the two of them, their efforts did indeed save this individuals life and that's no small effort on their part and it deserves the highest level of recognition that we can give them, which is the Lifesaving Award, which reads as follows: This Lifesaving Award is Presented to Sergeant Tom Haas in recognition of his actions on March 4, 2009 when he helped to save the life of an individual, presented this date March 17, 2009. We have a like presentation for Officer Rich Reynolds; This Lifesaving Award is Presented to Rich Reynolds in recognition of his actions on March 4, 2009 when he helped to save the life of an individual presented this date March 17, 2009. I also have two new lifesaving bars that you can wear, when you're not lifesavers so... I won't mention my store. I would like to call on Chief Ed Grennon, to see if he has something to say, I know he will."

Chief Grennon: "A comment from Sgt. Cranmer that I always have something to say. Sergeant Haas and Officer Reynolds exemplify through their actions, not only in this instance, but on a daily basis, the dedication to a community that all of the officers that I have a good fortune to work with demonstrate. They do this on a daily basis and I'm sure if you ask them that they'll tell you that they were just doing their job that day and didn't do anything special. Well, they did and they do everyday along with all the other men and women who work in our department. So, I would just like to congratulate them and thank them on a job well done."

Commissioner Vanaman: "Okay, that concludes my report Mr. Mayor. It was an outstanding job once again by these individuals and there's another example of your taxes doing the right thing."

Mayor Quinn reminded everyone of the forthcoming Third Friday events.

Commissioner Vanaman: *"As I indicated earlier in the meeting this pushes this project a lot further along and knowing that it's going to take several months for the approval through the UEZ it was felt that now was to be the time to finally put some dollars and cents into a resolution and as I had indicated we also just received very verbal preliminary approval today from Verizon and Atlantic City Electric that we will in fact be able to utilize the limited space on most of their poles. I believe there were three locations that have to be switched, because of certain conditions that they placed on it. But, this is a giant step forward, we've been talking about this for a year and a lot of people may have forgotten the fact that this is just not a crime prevention tool, but we're looking forward to being so much broader in the technology as far as having it being able to have this wireless mesh that will be able to feed into the police cars, various other City services and you may, not that far down the future have a truck riding down your street reading your water meter as he goes by and it will be automatically transmitted through this wireless mesh. So, it's been a year and we're finally getting closer to it."*

Commissioner Derella: *"this is an application for us to go ahead and apply to the UEZ, Mr. Ayres will take it from here. Also, if I'm not mistaken it has to go through the Attorney Generals Office as well for approval in regards to law enforcement."*

Commissioner Vanaman: *"and we're also putting this in now, because we want to jump in on this big tidal wave of money that's being thrown at all Public Safety aspects..."*

Commissioner Derella: *"correct."*

Commissioner Vanaman: *"we want a piece of it."*

Bob Tesoroni addressed the Board of Commissioners and made  
the following comments:

*"Good evening, Mr. Mayor and Commissioners, Bob Tesoroni,  
Howard Street, Millville. I just want to speak for a moment on  
the Pension Deferral Bill that was passed by the Assembly and  
the Senate and it's awaiting a signature by the Governor, which  
is expected, because he is the one that was pushing the bill.  
What's the Commissioners position on this?"*

Commissioner Derella: *"We've already budgeted our pension  
payment and right now we're waiting to see what the Governor is  
going to do. Again, our budget is done, so we have the money in  
place. My recommendation, if I'm in this seat would be to, if  
they say make it mandatory that we have to defer it, we would  
put it into an account, because I don't want to get ourselves in  
the situation that we did several years ago and maybe we can  
draw some interest."*

Bob Tesoroni: *"thank you very much. I think that's a  
prudent thing to do, because there's strings that are tied to  
this one this time and that being that on the deferral you will  
pay interest on the other end of it and I don't think that's the  
prudent thing to do. I think we owe the bill, it's on our needs  
list, or should be on our needs list and we should pay it.  
Thank you very much."*

Mayor Quinn: *"Thanks Bob. Yeah, I actually sat with the  
Governor, he invited me up in a caucus room and as you probably  
read today that Senator VanDrew was opposing it and he supports  
basically what Bob had said and what Joe had talked about too,  
of not doing it and you know, it was not a real popular thing  
with many of the Mayors with the Governor's suggestion."*

There being no further comments Mayor Quinn declared the  
public comment portion closed and asked for comments from the  
Commissioners.

There being no further comments from the Commissioners, the regular session was adjourned subject to the call of the chair, by the following vote. Yeas: Shannon, Derella, Vanaman and Quinn.
